- SUMMARY: Requires confidentiality of certain information submitted by selfinsurers to the Superintendent of Insurance; tracks language of Freedom of Access law.
- COMMITTEE AMENDMENT "A" (H-80): Allows self-insurer information to be used by Bureau for proper purposes; based on current law. (ADOPTED)

- SUMMARY: Provides for competitive state fund for workers' compensation insurance; still allows private insurance and self-insurance.
- CROSS-REFERENCES: LD 495, LD 497 (and LD 1322, providing for a funded study of alternative funding mechanisms).
- 1153 AN ACT TO ADJUST THE WORKERS' COM- ROLDE LV/WD PENSATION INSURANCE RATES CHARGED CARROLL, D VOLUNTEER AMBULANCE COMPANIES
- SUMMARY: Requires workers' compensation insurance rates for volunteer ambulance companies and volunteer fire departments to be based on the actual earnings of employees in their regular employment.

1158AN ACT TO CLARIFY INDEPENDENTHALLOTPND(1635)CONTRACTOR STATUS UNDER THE
WORKERS ' COMPENSATION ACTOTPND(1635)

SUMMARY: Allows workers to establish independent contractor status under the Workers' Compensation Act by signing a written agreement; indepen-dent status could still be established by common law rules as well.
