SUMMARY: This bill represents an updating of Maine law to reflect changes in the Council of State Government's Model Radiation Act that are appropriate for the administration of an adequate state radiation protection program. The Department of Human Services id designated as the Radiation Control Agency and is responsible for coordinating radiation activities. An Advisory Committee on Radiation may now be appointed by the Governor to make recommendations to the commissioner and furnish advice, as requested, on matters relating to the regulation of sources of radiation. Appropriate departments are assigned to coordinate administration of related issues. Other sections of the bill address licensing, DEP jurisdiction, user fees, training programs, record maintenance, federal-State agreements, judicial review and penalties.
