1138 AN ACT TO INCREASE THE MINIMUM WAGE Connolly M-ONTP
McHenry m-OTP-A
Hayes H-acc. m. rep.;
insisted on eng.
with C-A.
S-adhered to
M(ONTP)rep.

SUMMARY: Increases state minimum wage from the current level of \$3.35/hr. to \$3.90/hr. in 3 steps over a 3-year period.

COMMITTEE AMENDMENT "A" raises minimum wage to \$3.50/hr. as of Oct. 1, 1983 but eliminates the further increases (adopted).

HOUSE AMENDMENT "A" (H-286): adds fiscal note (Beaulieu).

SENATE AMENDMENT "A" (S-208): adds emergency clause and eliminates proposed increase; establishes study committee (Dutremble).

WORKERS AND THEIR FAMILIES Tuttle

SUMMARY of LD 386: Employer must continue the same general health insurance policies on the same cost basis for an injured worker and his family for 3 years from the date of injury.

SUMMARY of LD 1148: Does not impose duty for employer to continue coverage for 3 years; existing law gives a person 31 days after his coverage under group health plan to convert to an individual policy; this bill allows 30 days additional time to convert if coverage ceases because his employment ends as a result of an injury for which the employee claims workers' compensation benefits.

SUMMARY: All Dept. of Labor policies, rules, memoranda and instructions, rather than only promulgated rules, must be compiled to be easily usable by the public; this must be completed by July 1, 1984.
