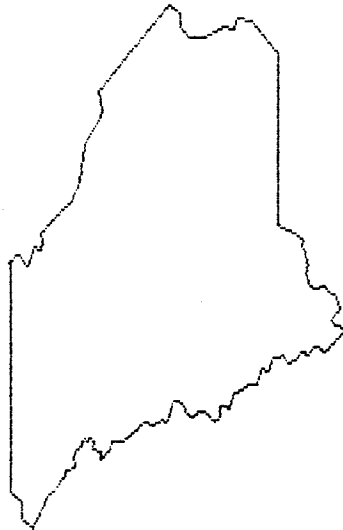

SUMMARY: Would give PUC the authority to interpret federal tax law and to take actions in conflict with federal agency policy, but not contrary to federal law.

SUMMARY: A bookkeeping measure that places filing fees and expense reimbursements collected by PUC in a dedicated fund and appropriates the money from the fund to PUC. Fines and unused funds go the General Fund.

Committee Amendment "A" (S-63) makes it clear that authorized refunds of filing fees may be made from the Public Utilities Commission Reimbursement Fund. Also requires that PUC report annually on the amount and use of any such fees.

SUMMARY: Would have increased the assessment on activities to support the regulatory fund by \$150,000 in FY 84, and \$50,000 more in FY 85. These are 11% and 3% increases. The number of positions is increased by (3) in FY 84 and (3) more in FY 85.
