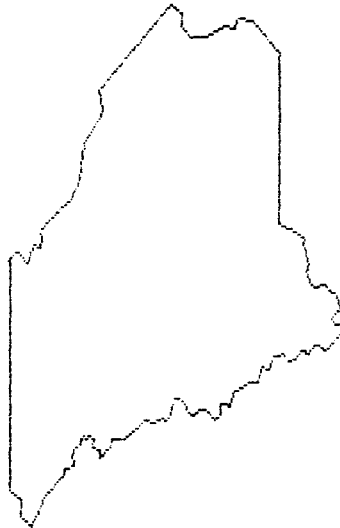

1361 AN ACT CONCERNING ATTORNEYS' FEES      Zirnkilton      LV/WD(acc.)  
IN WORKERS' COMPENSATION CASES      Perkins, T.

SUMMARY: Workers' Compensation claimant's attorneys fees may be awarded based on the commission's assessment of the claim's merits and the reasonableness of awarding partial or total fees.

1369 AN ACT TO REMOVE MINIMUM WEEKLY      Shute      M-ONTP(acc.)  
CHARGE FOR HANDICAPPED WORKERS      Kelly      m-OTP  
UNDER THE WORKERS' COMPENSATION ACT

SUMMARY: Eliminates \$25 minimum weekly workers' compensation benefit level for handicapped employees in sheltered workshops, and requires insurers to set rates based on actual average earnings of these employees rather than on industry wide averages.

SUMMARY: An employer who repeatedly violates labor safety laws shall, after conviction, be punished by a fine of not more than \$10,000 or up to 6 months imprisonment; bill eliminates requirement that the violation have actually caused death to an employee.

COMMITTEE AMENDMENT "A" (H-183): Penalties do not come into force unless the violation is a serious violation, which is defined as a violation where there is a substantial probability that death or serious harm could result from the violation (adopted).

1409 AN ACT RELATING TO REHABILITATION      Joseph      LV/WD(acc.)  
UNDER THE WORKERS' COMPENSATION LAW      McGowan

SUMMARY: Substantially expands the scope of rehabilitation services for disabled employees under the workers' compensation laws.

NOTE: Speaker's Select Committee on Workers' Compensation plans to work on this topic.
