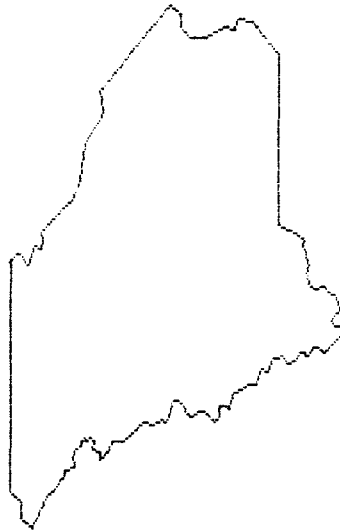

- 1349 RESOLUTION, PROPOSING AN AMENDMENT Kane PASSED CONRES 3  
TO THE CONSTITUTION OF MAINE TO PRO-  
VIDE THAT THE STATE MAY ENACT PROPER-  
TY TAX EXEMPTIONS RELATING TO WATER-  
CRAFT NOT SUBJECT TO FIFTY PERCENT  
REIMBURSEMENT
- SUMMARY: Removes watercraft from 50% reimbursement obligation. Will be submitted to the People in November.
- 1364 AN ACT TO AMEND THE LAW RELATING Hayden MAJ-OTP  
TO TAX INCREMENT FINANCING MIN-ONTP  
RECOMMENDED AND  
HELD OVER
- SUMMARY: Would permit captured value of a TIF district to be disregarded when calculating state valuation and revenue sharing.
- 1365 AN ACT TO PROVIDE A SPORTSMAN'S Paul ONTP  
INCOME TAX CHECKOFF FOR VOLUN-  
TARY SUPPORT OF FISH AND GAME  
MANAGEMENT
- 1389 AN ACT TO CHANGE THE METHOD OF McBreairty OTP-A  
FINANCING COUNTY SERVICES IN THE ENACT. PL 571  
UNORGANIZED TERRITORY
- SUMMARY: Eliminates obsolete laws. Establishes fund in each county for unorganized territory receipts and expenditures for municipal-type services. Establishes a budget procedure for counties with unorganized territory to parallel regular county budget process. Municipal cost component rate to vary by county according to level of expenditures.

- SUMMARY: Majority report containing unitary tax provisions enacted. Minority report same as majority but without unitary tax provisions.

TAX IMPLEMENTATION IDENTICAL TO  
THE FEDERAL IMPLEMENTATION
- SUMMARY: Refinement of LD 1378 to ensure that all fuel will be subject to 5 cents per gallon increase.
