1419 AN ACT TO CREATE AN UNCONTROLLED SITE CLEAN-UP PROGRAM AND TO PROVIDE FOR THE REMOVAL OF CERTAIN HAZARDOUS WASTE FROM THE MCKIN SITE IN GRAY, MAINE Diamond, G OTP-ND

New Draft LD 1750 held over in committee for further study.

SUMMARY: This bill appropriates funds for the clean-up of the McKin Hazardous waste site in Gray, Maine. It also provides that other available funds must be expended prior to the use of any newly appropriated funds.

1425 AN ACT TO AUTHORIZE EASEMENTS FOR THE PURPOSE OF SEWAGE DISPOSAL AND TO ELIMINATE UNDERSIZED RIGHTS-OF-WAY ON CERTAIN LEASED LOTS OWNED BY THE TOWN OF BRIDGTON Jackson PL 1983, c. 279

SUMMARY: This bill authorizes easements for the purpose of sewage disposal and to eliminate undersized rights-of-way on certain leased lots owned by the town of Bridgton.

1426 AN ACT TO CONTROL HAZARDOUS AIR POLLUTANTS Andrews PL 1983, c. 535

SUMMARY: This bill gives the Department of Environmental Protection the authority to control hazardous pollutants without having to set ambient standards. The bill also requires a study of hazardous pollutants. The Department of Environmental Protection is directed to recommend a comprehensive control program to the Legislature, based on health risk assessment, the extent of hazardous pollutants currently being discharged and available control technologies.
