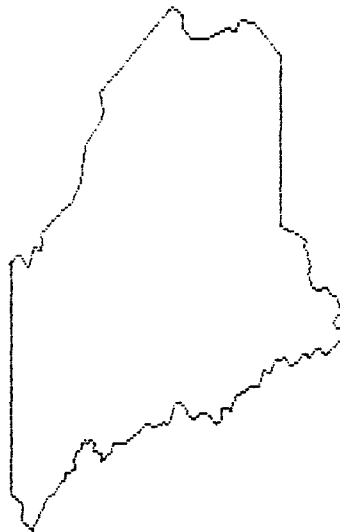

1408	AN ACT CONCERNING THE USE OF THE TERM 'WRESTLING'	Tuttle Jacques Tanmaro McGowan	ONTP H/S:acc.

SUMMARY: distinguishes between wrestling matches or contests in which contestants strive earnestly to win, and exhibitions or shows in which wrestlers display their skills without trying to win; exempts amateur school matches from regulations, regulates advertising and referees; sham or collusive matches made Class E crimes.

1432	AN ACT TO REVISE THE MARKUP PERCENTAGE FOR MAINE PRODUCED PRODUCTS UNDER THE LIQUOR LAW	Jalbert Charette Higgins, H. Dillenback	M-OTP-acc M-ONTP H/S:Indef.PP

SUMMARY: Reduces percentage markup by State Liquor Commission on Maine manufactured products from 75% minimum to 65% minimum; intended to assist competitive edge of Maine manufacturers competing against out-of-state competitors who warehouse liquor in Maine to reduce the markup on their products; this occurs because out-of-state producer's transportation costs are no longer included in the mark-up price; decreases General Fund revenues by \$252,345 per year.

1481	AN ACT TO PROVIDE A WARDEN'S ASSOCIATION HANDBOOK	Usher Roderick	OTP-A-acc PL 1983, c. 330

SUMMARY: Allows limited exception to Solicitations Law to allow state warden service association to sell handbooks if all proceeds are used for charitable services to members or their relatives; no ads may be included except for greetings from members.

COMMITTEE AMENDMENT "A" (S-95): wardens or association members may not sell the handbooks themselves, but may provide requested copies to nonmembers for sale to the public; this will prevent situations where people feel pressured to buy a handbook out of fear of harassment by wardens. (H/S: adopted)
