SUMMARY: Creates a program to abate, clean up and mitigate threats to public health and the environment from uncontrolled hazardous substance sites through the DEP. It establishes a prohibited acts section, a procedure for designating sites to be uncontrolled hazardous substance sites, certain defenses to the strict liability imposed by the bill, and it ties the forfeiture provisions of the bill to property or assets directly involved in violations of uncontrolled hazardous substance provisions.
