AN ACT TO ESTABLISH A SPECIAL AC- Wood QUISITIONS FUND AT THE STATE LIBRARY

SUMMARY: ID 1651 proposed to establish a separate carry-over account for the Maine State Library to purchase documents, maps, and journals. The intent is to enable the Maine State Library to purchase significant Maine documents that would otherwise be distributed outside the State or across the State.

SUMMARY: Redraft of ID 1570. This redraft would enable the Maine State Housing Authority to establish rules by which home fixtures would be defined to qualify for home energy improvement loans.

AN ACT AMENDING AND EXPANDING THE Jacques HOME WINTERIZATION PROGRAM STATUTE

SUMMARY: ID 1698 proposed to establish the Maine Fuel Assistance Act in statute and to coordinate the fuel assistance program with the weatherization program already defined in 22 MRSA §5201 et seq.. Since both programs use very similar criteria, inconsistencies are not a problem. Confidentiality of client records is also established by law.

1715 AN ACT TO ESTABLISH A JOB DEVELOPMENTE IN 1, P. ENG.
TRAINING FUND WITHIN THE STATE DEVELOPMENT OFFICE

SUMMARY: ID 1715 is a redraft of LD 1629 and proposed a job training program to be funded by a \$250,000 job training fund.
