SUMMARY: This bill and amendments from last Session was recalled from the Governor's desk this Session. It was not reassigned to the Committee, but the Committee did hold a work session to discuss the Governor's concerns with the bill. A House Amendment clarified that contractual obligations entered into by the Commissioner of Defense and Veterans' Services are subject to the approval of the appropriate Executive Branch agency, like contracts for other State agencies.

1873 AN ACT RELATING TO RETIRE- Kelleher LV/WD MENT COMPENSATION FOR JUNGES

SUMMARY: Would have provided a retirement benefit for District Court judges upon reaching 65 years of age if they had served at least 2 7-year terms prior to reaching age 65, but who were not reappointed. The bill was withdrawn in light of the Compensation Commission's review of judicial compensation which ultimately recommended establishment of a comprehensive judicial retirement system.
