1847 AN ACT TO INCREASE THE NUMBER OF SUPERIOR COURT JUSTICES AND DISTRICT COURT JUDGES

1848 AN ACT PROVIDING FOR CHANGE OF VENUE IN CRIMINAL CASES

SEN ADHERED TO ENGROSS-MENT HSE ADHERED TO FAILS ENGROSSMENT

SUMMARY: This bill sought to permit the Maine Supreme Judicial Court to provide by rule that post-arraignment proceedings in criminal cases may be conducted at locations other than those provided by statute. This would have enabled criminal trials to occur in a court other than one in the county where the crime was committed. The current statute permits such a transfer only with the consent of the defendant. Under the Maine Constitution, however, a criminal trial would still have had to occur within the "vicinity", interpreted by the Supreme Judicial Court to mean within the "neighborhood" of the crime, apparently ruling out the possibility of transferring a criminal trial to a non-neighboring county.
