AN ACT TO AMEND THE LAW 1364 RELATING TO TAX INCREMENT FENANCING

ENACTED Gov. held

- SUMMARY: Removes increased valuation in tax increment financing district from consideration in state valuation for purposes of school funding, county taxes, etc. Requires approval of director of State Development Office. Held over from 1st Regular Session
- 1885 AN ACT CONCERNING APPLICA- Moholland ENACT. TION OF FUEL TAX LAWS PL 1983, c. 808
- SUMMARY: Provides 1/2 rate fuel tax decals during last 3 months of the year. Provides refund of full Maine tax paid on fuel used and on which a tax was paid in another state (rather than the other state's tax as under previous law).

1887 RESOLVE, AUTHORIZING THE Mills RESOLVES c. 54 STATE TAX ASSESSOR TO CONVEY THE INTEREST OF THE STATE IN CERTAIN REAL ESTATE IN THE UNORGANIZED TERRITORY

SUMMARY: Permits sale of tax-acquired land in the unorganized territory.
