SUMMARY: Would establish maritime territory between mean low tide and three miles out. Provides that watercraft excise tax be paid to the State. State would reimburse municipalities for 50% of property tax loss and for services provided to residents and watercraft in the maritime territory.

SUMMARY: Provides for statutory reimbursement to municipalities which meet deadline for municipal valuation return and which meet 70% assessment ratio.
