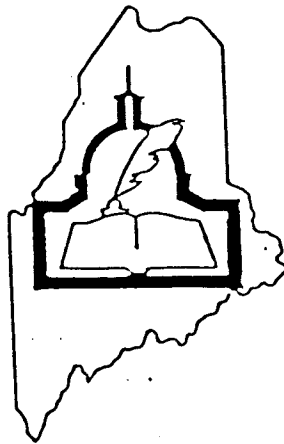

SUMMARY: This bill sought to permit the Bureau of Public Lands to construct, repair, or improve roads and bridges without supervision by the Bureau of Public Improvements as required in statute. The bill was withdrawn when BPL and BPI established criteria for simplified and expeditious review of road and bridge work, making a statutory change unnecessary.
