SUMMARY: The bill and Committee Amendment "A" allow municipalities to establish probationary periods for employees which shall not exceed 6 calendar months or the length of time in effect in a municipality on January 1, 1984, whichever is greater. Cause and hearing protections under Title 30 only apply to employees who have completed the probationary period established by the municipality.
