1939 AN ACT TO ESTABLISH WAGE-BASED COST-OF-LIVING

ADJUSTMENTS FOR RETIRED STATE EMPLOYEES, TEACHERS

AND BENEFICIARIES

SUMMARY: Would have changed, beginning in 1985, the basis for determining the cost-of-living adjustment for retirees from the annual change in the Consumer Price Index to the percentage increase in the salaries and salary related items received by active state employees The COLA for 1984 would have been 5%. teachers. discussion on the factors to be considered in determining percentage increase, how and by whom those calculations would be made and the actuarial cost of making such a change, the bill was withdrawn with the agreement of all parties concerned.

SUMMARY: Would have required the retirement system to pay a monthly benefit to Mrs. Martel equal to that paid to the spouse of a deceased member with 25 years of creditable service. Mr. Martel had 23 3/4 years of creditable service with the Town of Sanford when he died; and Mrs. Martel was not eligible for survivors benefits. letter was sent to the Town encouraging them to buy back additional prior service for its employees so that Mrs. Martel would qualify for the benefit which this resolve would have provided.
