2009 AN ACT TO ENABLE THE CITY OF Manning OIP-A  
PORTLAND TO CHARGE REASONABLE P&S 83, C. 67  
INTEREST ON DELINQUENT SEWER (EMERGENCY)  
ACCOUNTS

SUMMARY: The bill gave Portland the same right given to other municipalities in the First Regular Session, namely, to set the interest rate for delinquent sewer accounts at the same rate as for unpaid taxes.

The Committee Amendment (H-472) added an emergency preamble.

2092 AN ACT TO AMEND THE TRUSTEE Usher OIP-A  
APPOINTMENT PROCESS OF THE P&S 83, C. 74  
CUMBERLAND COUNTY RECREATION  
CENTER TO MAKE IT CONFORM  
MORE CLOSELY TO NEW LEGISLA-  
TIVE REDISTRICTING

SUMMARY: The bill amended current law which designated 1 trustee from each of the 2 Senatorial districts in Cumberland County and 7 at large.

Because of redistricting, the new provisions designate the appointment of 2 trustees from the City of Portland, 5 from specific combinations of towns, and 2 at large.

The Committee Amendment (S-304) made the Act effective on January 1, 1985, at the time new trustees are appointed by the Cumberland County Commissioners.

2114 AN ACT TO AUTHORIZE WASHINGTON L. Brown OIP-A  
COUNTY TO RAISE \$1,400,000 FOR P&S 83, C. 73  
RENOVATIONS AND ADDITIONS TO  
THE WASHINGTON COUNTY JAIL

SUMMARY: The bill authorized the issuance of bonds for renovations and additions to the Washington County jail, subject to approval in a county referendum.

The Committee Amendment (S-305) added language in the referendum section to clarify that the Commissioners must hold a referendum, but have discretion as to its date.
