SUMMARY: This bill repealed the provision for municipal snowmobile registration which was enacted by the First Regular Session of the 111th Legislature.

SUMMARY: Establishes a minimum fine for hunting without a license. The nonsuspendable minimum fine is \$50, plus an amount equal to twice the applicable license fee.

SUMMARY: This bill sought to establish a 15-mile per hour speed limit for motor vehicles operating on icebound inland bodies of water.
