2126 AN ACT TO ENCOURAGE THE USE Pearson
OF WOOD AS A SOURCE OF ENERGY
IN STATE-OWNED BUILDINGS

SUMMARY: Replaced by new draft LD 2383.

AN ACT TO REQUIRE NEW RESIDEN- McGowan
TIAL AND COMMERCIAL BUILDINGS
THAT USE ELECTRICITY AS A HEAT
SOURCE TO MEET THE STATE ENERGY
EFFICIENCY BUILDING PERFORMANCE
STANDARDS

SUMMARY: This bill sought to require owners of residential and commercial buildings constructed after Jan. 1, 1986 and heated with electricity to certify to the utility that the building met state energy efficiency building performance standards. Failure to so certify would require the payment of an installation fee by the owner to the utility. The bill was withdrawn because the Committee felt that purchasers of new buildings would seek energy efficiency and that the marketplace would therefore produce energy efficient buildings without state involvement.

2142 AN ACT CONCERNING THE OPEN Racine REPORT NOT ACCEPTED BURNING OF LEAVES AND BRUSH

SUMMARY: This new draft of LD 1867 was the majority report, but it was not accepted. The amended bill was accepted instead.

2152 AN ACT PROVIDING FOR THE ABAN- DOW DONMENT OF THE STATE-OWNED DAM ON DEAD RIVER, ANDROSCOGGIN COUNTY
