SUMMARY: Recodifies the Atlantic Salmon license and tag system. Institutes higher fees. Amended to limit the new regulatory authority of the DMR, to add two new river segments to the designated rivers and to reduce the limit on sport catch from 10 to 5. Amendments CA (H-521) and HA (H-524) accepted.
