2407	AN ACT TO PROVIDE A SALES TAX EXEMPTION FOR CERTAIN RESIDENTIAL FACILITIES NEW DRAFT REPLACES LD 1886		ENACT PL 1983 c. 851

SUMMARY: Sales tax exemption for incorporated non-profit temporary residential facilities for pediatric patients with critical illness or who are accident victims and adults with cancer and their families.
Cost \$625

2432	AN ACT TO AMEND THE STATE INCOME TAX CREDIT FOR THE INSTALLATION OF RENEWABLE ENERGY SYSTEMS	Mitchell, J	. ENACT. PL 1983 c. 840

SUMMARY: Reestablishes income tax credit for renewable energy systems (excluding wood furnaces) at 20% of purchase price, but not exceeding \$100. The Committee recommended raising maximum credit to \$500 but Appropriations reduced to \$100.
Cost - \$45,000.

2458	AN ACT RELATING TO MUNICIPAL COST COMPONENTS FOR FISCAL YEAR 1984-85 AND PROVIDING FOR A STUDY OF THE UNORGANIZED TERRITORY NEW DRAFT REPLACES LD 2148	Kilcoyne	EMERG. ENACT. PL 1983 c. 827

SUMMARY: -Establishes amount to be collected through the property tax in the unorganized territory for fiscal year 1984-85.
-Establishes a study of alternative methods of funding and providing services in the unorganized territory.
-Delay LURC charges to municipalities until July, 1985 pending the outcome of the study.
-Revises the procedure for municipalities withdrawing from LURC jurisdiction and conditions for reassertion of LURC jurisdiction.
