SUMMARY:

This bill would have clarified the type of low-level radioactive waste on which a service fee is levied, deleted the deadline of December 31, 1985 on the collection of that service fee (allowing for the continuation of the Low-level Waste Siting Commission beyond that date) and allocated funds from the Low-lvel Waste Siting Fund to the commission and DEP for the rest of the biennium.

AN ACT TO CREATE THE NORTHERN AND EASTERN MAINE EMERGENCY FORESTRY DISTRICT

SUMMARY:

The bill proposed the establishment of a special spruce-fir forestry district within which forest landowners could claim tax credits for expenses related to the management of spruce and fir. The intent of the bill was to provide the impetus needed to offset forecasted shortfalls in the supply of

spruce and fir. In addition to tax credits, the bill called for the establishment of a new agency to be part of the Department of Conservation whose responsibilities would include research, educational and extension, planning and marketing efforts. The original bill carried a General Fund appropriation of approximately \$3 million over a two year period. Foregone tax revenue was not estimated.

The Committee received two alternative versions of the bill from the Department of Conservation and from an economic development group known as "Pro-Maine". Both carried substantially smaller direct costs while still not formally estimating lost tax revenues. The principal differences between the alternative bills has to do with the size of the, landholding eligible for the tax credit. The DOC version allows all landowners to take the credit with the rationale that most of the spruce-fir forest is in large ownerships. Thus the actions of relatively few landowners can have a significant impact on the future condition and supply of the spruce-fir resource. Interestingly, large forest landowners were not enthusiastic supporters of the bill. The Pro-Maine version limited the tax credit to relatively small landowners reasoning that these landowners need special attention and incentives in order to manage their holdings properly.

The Committee decided to hold and study the bill due to the late referral of the bill and the complexity of the proposals involved.
