SUMMARY:  
This bill would have required a landlord to state good cause for evicting a tenant.  
Committee Amendment "A" (H-204) (Not accepted) required 30 days notice of eviction for listed "good cause" reasons, 30 days notice without stating cause for landlords with less than 5 units and 60 days for 5 or more units. The 7-day notice provisions in current law were retained.
