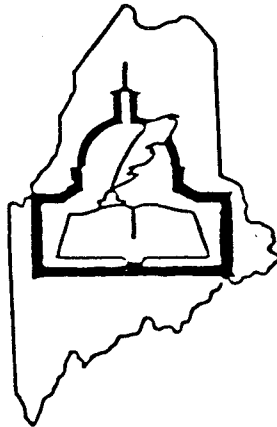

SUMMARY:

Establishes a statute of limitations for a civil action based on a sexual act or sexual intercourse with a person under the age of majority by providing that the action must be commenced within 6 years from the time the cause of action accrues. Also makes it clear that this statute of limitations is delayed while the plaintiff is under a disability, which includes the period during which the plaintiff is a minor. The limitation period starts to run, then, when the plaintiff reaches the age of majority unless he or she is under another disability which continues to prevent the running of the limitation period.

SUMMARY:

Sought to create easements by implication for installation of utilities when an owner of real estate abutting on a private way has a deeded right of ingress and egress upon that way. The owner of the easement for ingress or egress would have been permitted to turn that easement into one for the placement, installation, or construction along, under, or upon the private way of poles, pipes, conduits, manholes, etc., necessary for the transmission of gas, electricity, and telephone services.
