SUMMARY :

This bill eliminated some of the restrictions on when beano games may be conducted. Christmas day is the only day beano may not be conducted. Games may be held on Sunday after 12 noon, and no games may be conducted between 12 midnight and 7 am.

Senate Amendment "A" (S-6) and House Amendment "A" (H-11) added an allocation section to provide for State Police coverage of Sunday beano games.

SUMMARY :

This bill requires that upon a 3rd conviction or adjudication for operating under the influence, a defendant must undergo an alcohol treatment or rehabilitation program.

This bill would have required the Commissioner of Public Safety to investigate motor vehicle accidents involving law enforcement officers to determine if excess speed or a high speed chase may have caused the accident.
