SUMMARY:

Provides another year of testing of the use of night sessions of Small Claims Court by removing the current July 1, 1985 sunset on these provisions and replacing it with a November 1, 1986 sunset. Each District Court must be available at least one hour, one evening each month, or one hour on a Saturday each month, to hear small claims actions.

SUMMARY:

Sought to include in the crime of prostitution offering to engage in digital contact with the patron's sex organs in return for a pecuniary benefit. Current law refers to the crime of prostitution including sexual intercourse or a sexual act, but not sexual contact.

SUMMARY:

Adds prior convictions for burglary with the intent to commit theft and robbery, a crime in which theft or attempted theft is always an element, to those already listed in the Maine Criminal Code to be used in classifying new theft charges as Class C. This change is in keeping

with the intent of the Criminal Code that persons with a history of at least 2 prior property theft offenses should be charged with Class C offenses in any new theft conduct. Also allows new attempted theft offenses to be charged as Class C, which is consistent with the policy determination that prior attempted theft convictions may be used in classifying new theft offenses as Class C.

SUMMARY:

Clarifies who may assist the Commissioner of Mental Health and Mental Retardation and the Commissioner of the Department of Human Services (DHS) in acting as public guardians, defines the circumstances under which vital records may be amended, adds a definition of "abuse and neglect" to the statutes concerning disclosure of records of certain facilities licensed by the DHS, and further clarifies these licensing statutes with regard to mandatory disclosure of child or adult abuse or neglect information by the DHS to an investigating law enforcement agency.
