#### SUMMARY :

The purpose of this bill is to require transient sellers to disclose their state license number and permanent address to consumers and require the license number and permanent address to appear on any advertisements the transient seller may take out and on a receipt given at the time of sale.

SUMMARY :

The bill was intended to ensure that state insurance requirements for interstate motor carriers are consistent with federal requirements so that tour busses are not discouraged from scheduling tours to Maine. The problem was resolved by a change in Dept. of Public Safety rules.

The purpose of this bill is to facilitate the return of used vehicles when the vehicles have been sold with rolled back or tampered odometers by allowing consumers to return the vehicle and obtain a refund of the full purchase price.
