SUMMARY:

This is a new draft of LD 438. Existing State law allows the open burning of solid waste at municipal dumps serving less than 1,000 people, unless the BEP finds that such burning is actually causing violations of air quality standards. Open burning is a violation of federal regulations. The original bill would have prohibited open burning at those dumps still doing so after July 1, 1986.

The new draft allows more time for municipalities to stop open burning. They must submit a plan acceptable to the BEP for alternative solid waste disposal by July 1, 1986; the plan must be implemented by January 1, 1989.

SUMMARY :

The bill established a fee schedule for businesses required to register under the "Chem ID Law". The schedule was based on number of employees. The schedule in this new draft of LD 1064 was less expensive for small businesses and more expensive for large firms. The overall revenues raised by the bill were comparable to those of the original bill.
