> JOINT STANDING COMMITTEE BILL SUMMARIES MAY 1986

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears. . . . .

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

The bill also makes it clear that evidence gathered during an investigation of a discrimination complaint may be used as evidence in any subsequent civil or criminal proceeding, unless the evidence comes within the exception regarding confidentiality of settlement negotiations.

<u>SUMMARY:</u> Under federal law, state agencies are required to see that construction and construction-related firms which are owned and controlled by minorities, women and other disadvantaged groups have the opportunity to participate in federally-funded transportation projects. In certifying these firms as eligible, state agencies obtain from applicants certain records which are considered confidential business records. This bill prevents public disclosure of this information.

<u>SUMMARY:</u> LD 1785 provides court mediators with immunity from liability for negligent quasi-judicial, quasi-legislative, and discretionary acts committed within the scope of their duties as mediators. This immunity is similar to the immunity provided state employees under the Maine Tort Claims Act.

If further mental examinations are to be conducted, and the defendant remains incarcerated, an initial examination to determine if the defendant must be committed to the custody of the Commissioner of Mental Health and Mental Retardation must be completed within 90 days. If no long-term observation is found to be needed, the further examinations must be completed within 30 days.

LD AN ACT ESTABLISHING AN IMMUNITY FROM CIVIL LVWD 1787 LIABILITY FOR CERTAIN SHELTERS FOR THE HOMELESS

<u>SUMMARY:</u> This bill sought to provide immunity from civil liability for injury or death for charitable or nonprofit organizations, their employees, and volunteers, where the organization provides shelter to any person in good faith and without charge. The immunity would not have applied in cases of gross negligence, recklessness, or intentional misconduct.

This bill was withdrawn upon receipt of a memo from the Attorney General advising that the doctrine of charitable immunity applies to charitable shelters and their employees. This common law doctrine makes charities immune from tort liability. A statute (14 MRSA §158) does abrogate this immunity to the extent the charity is covered by insurance.
