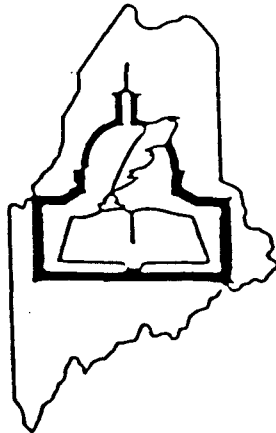

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: This bill sought to add 2 community representatives to the Alcohol and Drug Abuse Planning Committee. It was referred to this committee by the Joint Standing Committee on Human Resources. It was withdrawn.

LD AN ACT TO MAKE ADDITIONAL ALLOCATIONS FROM THE P&SL 1985  
2277 ALCOHOL PREMIUM FUND c. 134

Committee Report: New draft of LD 1365

SUMMARY: Public Law 1985, ch. 803 (LD 1370) doubled the tax on alcohol dedicated to the alcohol premium fund and provided that, beginning in 1987, the allocations from that fund will be reviewed by the Joint Standing Committee on Appropriations and Fiscal Affairs.

This new draft allocates the money from the Alcohol Premium Fund that is expected from the increased tax. LD 1365 was held over from the First Regular Session of the 112th Legislature. In the new draft the allocations have been adjusted to reflect the reduced time period remaining in this fiscal biennium. In addition, the new draft adds language to ensure that if federal legislation reduces funding for current programs, this money will be applied to existing programs prior to funding of expanded programs.
