SUMMARY: This bill sought to have all payments received for the boarding of prisoners placed in a fund which would only be used for improvement and operation of the county jails.

In the previous session, a similar bill had been introduced for Somerset County except that is specified a dollar amount rather than requiring the placement of all payments to the fund. However, this bill was passed with an amendment that provided the requested funds from the General Fund rather than from the boarding of prisoners.

The Committee felt that LD 2026 infringed on the budget rights of the County Commissioners and the Legislative Delegation.

Last year there were 4 bills which sought to remove individual county budgets from legislative approval: Kennebec, Aroostook, Waldo and Cumberland. Kennebec legislation was developed by MMA and was the model for Aroostook and Waldo. Kennebec and Aroostook were amended so that the Legislature still has budget approval. prototype for Kennebec and the application of it by committee staff to Waldo did not deal with the statute that sets the county officer salaries. The Cumberland bill removed the county from the provisions of the salary section. This is the preferrable approach and the one that this bill does for Waldo County.

Committee Amendment A eliminated the provision that set county salaries, since the other portion of the bill made the statutory setting of salaries unnecessary.
