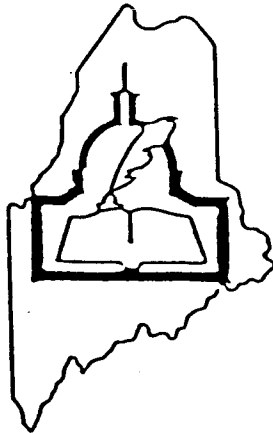

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

LD AN ACT TO CLASSIFY AIDS AS A DANGEROUS
2085 COMMUNICABLE DISEASE FOR THE PURPOSE OF
PUBLIC HEALTH

SUMMARY: This bill sought to classify AIDS as a dangerous communicable disease. It detailed the rules to be promulgated by the Department of Human Services for the identification of employment situations where exposure to AIDS is the greatest, for a means of identification of AIDS victims, and for notification and precautionary measures concerning AIDS. It also required that in the case of death of an AIDS victim, any person disposing of the body shall be notified that the deceased had AIDS.

This bill was withdrawn. AIDS has already been classified as a dangerous communicable disease and is subject to Department rules outlining safety procedures.
