All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: The original bill created a new method of administering Vocational Region I. It gave more authority to the superintendents and replaced the vocational region director with a coordinator.

The New Draft of the bill disolves Vocational Region I. It provides for a procedure whereby vocational services for the schools in that area will be provided by three vocational centers organized in the same manner that vocational services are organized in the Central Aroostook County Region. The new organizational structure shall go into effect at the beginning of fiscal year 1987-88. The amendment makes the dissolution of the present Vocational Region I effective on July 1, 1987.
