This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: L.D. 2344 attempted to create legislative oversight over the closing of unemployment offices in the State. It would not have allowed any unemployment office in the state to be closed until the Commissioner of Labor had notified the Labor Committee of his or her intention to do so, and at any rate, until 91 days after the end of the next legislative session.

L.D. 2360 replaced the original draft and simply requires the commissioner to establish and maintain an unemployment office, staffed by at least one full-time claims interviewer, in the municipality of Sanford.

Senate Amendment "A" (S-544) removed the emergency preamble and clause from the bill.

House Amendment "A" (H-741) changed the bill's title to "AN ACT to Maintain the Sanford and Madawaska Unemployment Offices" and added a requirement that the Madawaska Unemployment office also be kept open with at least 2 full-time claims interviewers.
