LD AN ACT REGARDING THE GENERATION OF ELECTRIC POWER AND HIGH-LEVEL RADIOACTIVE WASTE.

Sponsor: Initiated Bill

Committee Report: Maj-ONTP - Min-OTP

SUMMARY: The bill was initiated by the state's voters following a successful signature collection effort. The bill proposes a ban on the generation of high-level radioactive waste at nuclear power stations after July 4, 1988. The intended effect of this legislation would be to close the Maine Yankee nuclear power station at Wiscasset, Maine. The committee majority voted against the bill which has the effect of sending the question to the voters in the fall of 1987. The committee minority voted in favor of the bill. Efforts to change the wording of the ballot question through legislation (see LD 119 - Legal Affairs) were unsuccessful.

LD AN ACT TO CLARIFY THE DESCRIPTION OF THE CROOKED LVWD

26 RIVER IN CUMBERLAND COUNTY AND TO EXTEND

SPECIAL PROTECTION TO OUTSTANDING RIVERS TO THE

CROOKED RIVER

Sponsor: BLACK, Ruhlin, Greenlaw, Jackson Committee Report: LVWD

SUMMARY: The bill made a technical correction in the geographic description of the portion of the Crooked River which is subject to certain land use controls under the 1983 Maine Rivers Act. The bill also included the same portion of the Crooked River in the provisions of the Rivers Act that bans new hydropower development without prior legislative authorization and severely restricts the redevelopment of existing hydro facilities. The committee voted unanimously against the bill, taking the position that any "reclassification" of Maine rivers should take place in the context of a comprehensive review of all Maine rivers. The bill was recalled from legislative files after the committee report was accepted. However, the effect of this action was simply to change the committee report from "ought-not-to-pass" to "leave-to-withdraw".
