AN ACT CONCERNING THE APPROVAL OF VOTING PL 1987 LD 74 DEVICES c. 96

Sponsor: DIAMOND, Bost, Cote Committee Report: OTP-A Amendments Adopted: H-65 COMMITTEE

SUMMARY: This bill allows the Secretary of State to make reasonable rules concerning the use and type of voting devices to limit the cost of producing ballot materials or to avoid voter confusion caused by differing voting systems. The bill also removes a reference to "special marking devices" because electronic voting systems do not use any.

Committee Amendment "A" (H-65) allows the Secretary of State to make rules, but gives municipalities flexibility. Municipalities may choose a device or system approved by the Secretary of State, but, if the device or system is not also recommended by the Secretary of State, the municipality must pay the State the difference in costs incurred by use of the not recommended device or system.
