SUMMARY: The current statutory and actual fee for examining and licensing a chiropractor is \$40. This bill seeks to place in statute a ceiling of \$100 for examining and licensing. According to the Board of Chiropractic Examination and Registration it is the plan to raise the fee to \$50 at this time but they wish to raise the allowable ceiling beyond this point so that there will not be need for frequent submission of bills such as this.

Committee Amendment A: This amendment adds an allocation section to reflect the increase in dedicated revenues which will arise from an increase in registration fees. Even though the original bill allows fees of up to \$100, the allocation is based on testimony that for the 2 years in question the fee will only be raised from \$40 to \$50.

House Amendment A: This amendment adds a provision to increase license renewal fees from \$50 to \$100 which will bring these renewal fees in line with the initial license fees contained in the original bill. Having the renewal fees increased was apparently intended in the original bill, but the correct section was not changed.

This amendment also shows an increase in allocation and dedicated revenues to reflect implementation of the total fee increase in the first year of its authorization. An earlier committee amendment contained an allocation amount which did not reflect the full impact of the total allowed fee increase in the first years of its authorization.
