SUMMARY: Currently, the State pays for the facilities required for District Courts. However, counties provide at no charge such facilities for the Supreme and Superior Courts as were used by these courts in 1976.

This bill removes the requirement that the counties provide the Supreme and Superior Court facilities at not charge.

The Committee amendment adds an appropriation section showing the additional funds needed to lease court facilities which are now provided at no cost by the counties.
