LD AN ACT CONCERNING PASSING A SCHOOL BUS WITH 1146 FLASHING RED LIGHTS.

Sponsor: NORTON, Gould RA, Bailey Committee Report: ONTP

SUMMARY: This bill would have made the registered owner of a vehicle which passes a school bus which has its flashing red lights on guilty of a Class E crime, whether or not the owner is the actual operator.

SUMMARY: The original bill provided that the expiration dates of motor vehicle registrations and inspections, including motor-driven cycles, will coincide in 1988. The bill also required the Secretary of State to provide notification between 30 and 60 days prior to the expiration of the registration. It also exempts dealers and transporters from having to display inspection certificates on the vehicles they own, but requires that the vehicle meets-the inspection standards if it is operated on public highways. It also requires that dealers provide a valid certificate of inspection on the day of the sale of transfer of a vehicle. The bill also contains specific requirements for the date of the coinciding expiration of inspection and registration, and requires that any person other than a dealer who sells of transfers ownership of a vehicle must remove the inspection sticker prior to the transfer.

- Committee Amendment "A" (S-174), as enacted, amended the implementation date for motor-driven vehicles, deleted the section on notification of registration expiration, and added an effective date of July 1, 1988.
