LD AN ACT TO CREATE A PUBLIC SERVICE CABLE CHANNEL 1276 CONNECTED WITH THE UNIVERSITY OF MAINE SYSTEM LVWD

Sponsor: BOTT, Hichborn, Crowley, Clark N. Committee Report: LVWD

SUMMARY: The bill requires that every operator of cable television in the State make available a channel for public service use by the University of Maine System, to the extent as authorized by federal law.

The Federal Cable Communication Policy Act of 1984 (PL 98-549) (47 U.S.C. Subchapter V-A) limited the ability of the franchising authority (in Maine the municipality) to regulate rates and programming, but allows a franchising authority to establish requirements that channel capacity be designated for public, educational or governmental use.

LDAN ACT TO EXTEND THE BOUNDARIES OF THE PRESQUEP&SL 19871281ISLE SEWER DISTRICT AND THE PRESQUE ISLE WATERc. 34DISTRICT

Sponsor: LISNIK, MacBride, Collins Committee Report: OTP-A Amendments Adopted: H-214 COMMITTEE

SUMMARY: The bill expands the territory of the Presque Isle Sewer District and the Presque Isle Water District, and requires Public Utilities Commission approval of any sewer system construction.

The amendment deletes a redundant description of the territory of the sewer district and deletes a reference to the Public Utilities Commission regulation of the sewer district which is now outdated. Based on a Law Court decision, the Public Utilities Commission has not regulated any sewer districts for many years. Finally, the amendment adds a local referendum for approval of the expansion of the territory of the districts.

LDAN ACT CREATING THE FAYETTE WATER DISTRICTCARRY-OVER1311

Sponsor: KANY, Norton Committee Report: CARRY OVER

SUMMARY: The bill establishes the Fayette Water District, with the same boundaries as the Town. The Town has already voted to establish the district. It is not clear whether there are immediate plans to develop a water supply.
