LD AN ACT TO RECODIFY THE PUBLIC UTILITIES LAW 1458 (REPORTED PURSUANT TO PUBLIC LAW, CHAPTER 481 OF 1985) PL 1987 c. 141 EMERGENCY

Sponsor: Committee Report: New Draft of LD 350.

SUMMARY: The new draft makes technical changes to the bill, especially to new Title 35-A. No substantive changes are added.

The original bill is the result of a study by the Joint Standing Committee on Utilities which recodifies Title 35 of the Maine Revised Statutes by repealing it and replacing it with new Title 35-A in order to reorganize the body of law governing public utilities into a more logical format; to delete obsolete provisions; and to clarify some of the more archaic and older provisions, but not to produce substantive changes. In addition, the bill does include one substantive change, as suggested by the Audit and Program Review Committee: a statement of purpose for the Public Utilities Commission is added in §101 of new Title 35-A.

The bill moves a provision on telecommunications for the deaf to Title 22 and provisions on railroads to Title 23, and moves the substantive requirements for regulation of ferries in Casco Bay from the Private & Special Laws to Title 35-A.

Part B of the bill changes cross references elsewhere within the statutes from old Title 35 to new Title 35-A.

The effective date of the bill is July 1, 1987 to allow the actions of this Legislative session to be easily incorporated into new Title 35-A.

LDAN ACT TO PROVIDE FAIR PRICING IN MOVINGLVWD1503TELEPHONE LINES

Sponsor: HEPBURN, Matthews, Holt, Stanley Committee Report: LVWD

SUMMARY: Existing law requires a municipal permit for cutting or moving utility poles and wires. It also requires Public Utilities Commission approval of cutting or moving utility wires and poles used for transmitting train orders or operating block signals unless the mover and the utility agree.

The bill extends Public Utilities Commission approval to all utility wires or poles, unless the mover and the utility agree on terms, and it prohibits excessive fees when the movement of the wire or pole is required in order to move a building.
