LD An Act Relating to the Expiration of a Valid Certificate of ONTP
1934 Inspection on a New or Used Motor Vehicle

SUMMARY

Under present law, the dealer must remove the inspection certificate when a vehicle comes into his control and place a new certificate on it before it is operated on the highway. Upon sale for operation on the highway, the vehicle must have been inspected within 30 days. The bill extends the time to 90 days.

A new section of law will become effective July 1, 1988 which requires the vehicle in the dealer's hands to meet inspection standards when operated on the highway but does not require a sticker as such at that time. Then, a new inspection sticker must be issued on the day of sale. The bill does not address the new July 1, 1988 law.
