### SUMMARY

The bill changed the filing date of a report by the Therapeutic Pharmaceutical Monitoring Panel to the Governor and Legislature for 1988 from June 30 to July 30 but does not make a similar change for 1989.

## SUMMARY

Both the original bill and the amended version require gasoline stations which provide a discount for self-service over full-service to provide full-service to handicapped drivers at the discount price. The handicapped driver would have to display a handicapped license plate or placard.

The amendment limited the provision to more severely handicapped drivers -those who require special adaptive equipment in order to drive a car.

Two House amendments would have expanded the types of gas stations which would have been required to give a discount to handicapped drivers. Another would have substituted a \$50 credit on the handicapped drivers excise tax.

The bill would have required motor vehicle insurers and repairers to clearly indicate when parts used to repair a motor vehicle were produced by a manufacturer other than "the original equipment manufacturer of the motor vehicle." The intent was to make the consumer aware that the parts used to repair the vehicle were not original parts and that they may not be of the same standard as the original parts.
