All Adopted Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor for floor amendments. Final action is listed to the right of the title. If final House and Senate action differ, both are listed. Committee Reports and Floor Action are indicated as follows::

SUMMARY

This bill was designed to help alleviate the long-term care crisis by increasing the reimbursement rates for home care staff. It established statutory criteria for determining the levels of reimbursement in rate structure established by the Department of Human Services for home health care providers. The Committee Amendment (S-401), adjusted the monthly limits on costs per individual receiving in-home services as an alternative to institutional care to at least \$1,878 for skilled level care and \$1,361 for intermediate level care. It also added a fiscal note, an allocation and an appropriation.

SUMMARY

This bill sought to establish procedures for the control of AIDS, including the establishment of contact tracing and anonymous contact referral programs by the Department of Human Services.

It also would have established the testing for exposure to AIDS of certain persons and required some employees with AIDS to notify their employers.

It also dealt with other notification issues and mandatory testing.
