## SUMMARY

The Maine Coastal and Inland Surface Oil Clean-up Fund, formerly the Maine Coastal Protection Fund, was established in 1969, with a fund ceiling of \$4,000,000, to provide funds for Department of Environmental Protection personnel and equipment to be used in the abatement of oil pollution, and to promptly compensate persons damaged by oil spills. The fund ceiling has been altered over the years, with the cap now established at \$4,500,000. Over the last 20 years, the cost of all clean ups and 3rd-party compensations have risen dramatically. This bill raises the ceiling of the fund to \$6,000,000.

This bill increases the fees assessed upon each barrel of oil imported into Maine. The new fee requires the payment of 3¢ per barrel for crude oil, gasoline and all other refined products. At present importation levels, the fund should reach \$6,000,000 in approximately 4 years.

The committee amendment (S-303) clarifies the per barrel basis for the license fee and adds an allocation section and a fiscal note.

### <u>SUMMARY</u>

The original resolve authorized the Director of the Bureau of Public Lands to repair, maintain and operate the Mattawamkeag Lake Dam to ensure sufficient water levels in the lake to support wildlife, and to protect the interests of shoreline property owners. The resolve authorized the Bureau of Public Lands to acquire by eminent domain, purchase or gift, land together with all right, title and interest in and to the Mattawamkeag Lake Dam.

The committee amendment (H-647) allows the Department of Inland Fisheries and Wildlife to acquire the Mattawamkeag Lake Dam by eminent domain to clear any title problems, provided that there is a legal entity willing to compensate the department for the cost of acquiring the dam. It also allows the dam to be leased by another party to take over responsibility for repairing, maintaining and operating the dam.

The Department of Inland Fisheries and Wildlife will establish the water level and may require the lessee to construct a fishway as part of the dam.
