This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 51 **An Act to Increase the Flexibility of Survivor Benefit Laws** **ONTP**

SUMMARY

This bill allows a retiree to change beneficiaries with the agreement of the original spouse. Under current law, when a retiree divorces, the retiree is unable to remove the divorced spouse as the retirement survivor benefit beneficiary.

LD 107 **An Act to Require the State to Pay Medicare Costs for Retired State Employees and Retired Teachers** **CARRIED OVER**

SUMMARY

This bill requires the Maine State Retirement System to pay Medicare Part B premiums for state retirees and retired teachers.

LD 137 **An Act to Change the Time Required for Purchase of Armed Forces Service Credit** **LV/WD**

SUMMARY

This bill changes from 15 to 10 the number of years of state service required to be eligible to purchase credit for service in the armed forces.

LD 221 **An Act to Decrease the Number of Years of Service Required for Receipt of Retirement Benefits** **ONTP**

SPONSOR(S)	COMMITTEE REPORT	AMENDMENTS ADOPTED

SUMMARY

This bill changes the required number of years of creditable service for a surviving spouse to receive benefits to 20, but provides that an actuarial equivalent of 1/25 of the benefit due with 25 years of service would be deducted for each year of total service that is less than 25 years. Currently, a member of the Maine State Retirement System must reach age 60 or have 25 years of service to qualify for retirement benefits.
