LD 167 An Act to Amend the Law Governing Abandoned Vehicles

SUMMARY

This bill would have amended the law concerning abandoned vehicles. The bill provided for the reduction of the period after which a vehicle may be considered abandoned from 30 to 14 days. The bill would have allowed ownership of a vehicle to transfer to the owner of the premises or property when notice has been returned, unclaimed or refused.

Additionally, the bill would have decreased the civil fine for holder of an abandoned vehicle who does not comply with the law, from \$25 to \$5 per day, and added a requirement that only holders who knowingly violate the law may be fined and lose their claim to storing fees.

This bill was withdrawn in light of LD 653 which dealt with the same topic.

SUMMARY

This bill would have allowed the Secretary of State, upon evidence of completion of the registration process, to authorize the use of a flag plate in place of a regular front motor vehicle registration plate.

Committee Amendment "A" (S-24) replaces the original bill. The amendment allows the Secretary of State to sell flag plates independent of the registration process and prescribes how the plates must be attached to a registered vehicle. It authorizes municipal agents to issue flag plates and collect a \$1 service charge. The amendment includes an emergency preamble and clause, an allocation and a fiscal note.
