All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

LD 186 An Act to Continue Milk Pool Payments to Dairy Farmers Affected by the Newport Plant Closure

SUMMARY

This bill modifies the method of calculating milk pool payments for Boston market producers whose milk is hauled directly to Boston. It ensures that Boston market producers who previously shipped their milk to the plant in Newport will continue to receive full milk pool payments whether or not their milk is collected at a federal reload station before being shipped to Boston. This bill was enacted in response to the closing of the Newport plant.

LD 197 An Act to Amend the Laws Governing Superintendents of Pulling Events

SUMMARY

Public Law 1989, c. 153 prohibits a person's participation in pulling events if that person has violated laws governing cruelty to animals within the previous 5 years. This bill would have amended that law to apply only to violations occurring after May 19, 1989.

LD 337 An Act to Amend the Laws Pertaining to Horsemen's Purse Accounts and Racetrack Improvements

SUMMARY

This bill proposed to lower the threshold at which excess revenue generated from regular and exotic wagers must be returned to commercial meet licensees by the Treasurer of State. The decreased threshold was proposed due to the closing of a racetrack in 1989, making the \$37,000,000 threshold unrealistic. One half of the returned funds was to be used to supplement horsemen's purse money and 1/2 was to be used for the improvement of racing facilities.

LD 944 as amended by House Amendment "D" (H-672) to Committee Amendment "A" (H-541) lowers the threshold to \$33,500,000 and specifies conditions that must be met for commercial licensees to receive reimbursement for improvements. Commercial licensees must have their plans for improvements approved by the commission prior to making the improvements. The commission must verify that the improvements have, in fact, been made and the improvements must have been made in the year during which the funds were generated.
