This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature. The volume is organized alphabetically by committee; within each committee, the summaries are arranged by LD number. A subject index is provided at the beginning of each committee's summaries.

All adopted amendments are listed, by paper number (e.g., H - 584 or S - 222), together with the sponsor for floor amendments. Final action on each bill is listed to the right of the title. Various types of final action are abbreviated as follows:

**LD 225      An Act Regarding Court Security in Androscoggin County      LV/WD**

**SUMMARY**

The bill would have given the Judicial Department authority to hire qualified personnel as state employees to perform court security functions in Androscoggin County. See similar bill, LD 1458.

**SUMMARY**

The bill places the responsibility for the creation and issuance of forms of the Uniform Traffic Ticket and Complaint with the Commissioner of the Department of Public Safety. The Chief Judge of the District Court must first approve the forms.

Committee Amendment "A" (S-54) adds an appropriation and a fiscal note.

**LD 243      An Act Regarding the Operation of the Superior Court      PUBLIC 130

**SUMMARY**

The bill allows qualified persons other than people with judicial experience to serve as chairs of medical malpractice prelitigation screening panels.

Committee Amendment "A" (H-127) adds an emergency and revises who may sit as a screening panel chair. The Chief Justice of the Superior Court may appoint a person with appropriate trial experience to chair a panel, but each side may exercise one challenge to the choice of chairs. The Committee Amendment further clarifies the procedure for imposition of sanctions when a party fails or refuses to comply with rules or orders of the chair.

**LD 253      An Act to Limit the Liability of Charitable Institutions      LV/WD**

**SUMMARY**

The bill would have limited the liability of charitable institutions to the same amount for which governmental entities may be liable under the Maine Tort Claims Act: The limits of coverage in any insurance policy or the absolute cap of \$300,000.
